APPLICATION ON BEHALF OF THE PETITIONER/ APPLICANT FOR
AMENDMENT OF THE PRESENT PETITION

1. That the Petitioner, Gujarat UrjaVikas Nigam had filed the Petition seeking amendment in the Order No. 03 of 2020 Dated 08.05.2020, in the matter of Tariff framework for procurement of power by distribution licensees and others from Solar Energy Projects and other commercial issues for the State of Gujarat notified by Hon'ble Commission vide Order No. 03 of 2020 Dated 08.05.2020. The Petition had been filed for giving effect to the modification notified by Government of Gujarat vide GR dated 01.09.2020 in relation to Solar Power Project set up by MSME (Manufacturing enterprises) for providing energy accounting on 7.00 hours to 18.00 hours on the same day instead of 15 minute time block basis as per earlier GR dated 26.09.2019. Further, the rate for compensation for surplus injection is amended to Rs. 2.25/Unit instead Rs. 1.75/Unit.
2. That the matter was heard by Hon'ble Commission on 28.01.2021 wherein the Petitioner had submitted that the appropriate amendments in the relevant clauses of GERC (Net-Metering Rooftop Solar PV Grid Interactive Systems) Regulations, 2016 as amended



from time to time (referred to as "Net-Metering Regulations") needs to be carried out corresponding to the provisions of GR dated 01.09.2020 issued by Government of Gujarat.

3. The Hon'ble Commission after noting that the Petition does not refer to such prayer had granted liberty to file a separate petition or amend the present Petition.
4. That further the Hon'ble Commission had directed impleadment of various parties.
5. In light of the fact that the present Petition is already pending, the Petitioner is seeking permission of this Hon'ble Commission to amend the Petition in the following manner:-
 - (a) The Cause title of the Petition may be replaced as follows:

"Petition under Section 61 (h) read with Section 86 of the Electricity Act, 2003 seeking amendments in the Tariff framework for procurement of power by distribution licensees and others from Solar Energy Projects and other commercial issues for the State of Gujarat notified by Hon'ble Commission vide Order No. 03 of 2020 dated 08.05.2020 and in the relevant provisions of GERC (Net-Metering Rooftop Solar PV Grid Interactive Systems) Regulations, 2016"

- (b) After Para VIII of the Petition, the following Para may be added:-

"viii-a. The Petitioner submits that in order for the DISCOMS to implement the amendments to the Gujarat Solar Policy 2015 notified vide GR dated 01.09.2020, there is a need for issuing appropriate amendments in the GERC (Net-Metering Rooftop Solar PV Grid Interactive Systems) Regulations, 2016 notified by Hon'ble Commission. Accordingly, the Petitioner requests the Hon'ble Commission to initiate the appropriate proceedings for amendment in the said Regulations."



(c) After Para (ix)(b) of the Petition, the following prayer may be added:-

"(c) To Initiate proceedings for appropriate amendments in the GERC (Net-Metering Rooftop Solar PV Grid Interactive Systems) Regulations, 2016 to implement the amendments Issued by State Government vide GR dated 01.09.2020 in Gujarat Solar Policy 2015

(d) The earlier Paras (ix)(c) and (d) may be renumbered as (ix)(d) and (e).

"(d)The Petitioner craves relief of the Hon'ble Commission to allow further submissions, prayers, additions and alterations to this Petition as may be necessary from time to time.

(e) Pass any other Order as the Hon'ble Commission may deem fit and appropriate under the circumstances of the case, to avoid further delay and in the Interest of Justice."

A copy of the amended Petition is annexed hereto and marked as Annexure 1.

6. It is submitted that the present Amendment is necessary for adjudication of all issues arising out of GR dated 01.09.2020.

7. That the Hon'ble Commission had further directed in Order dated 03.02.2021 to implead the following parties as respondents to the petition by filing an amended memo of parties and serving copy of the amended petition to respondents.

MOST RESPECTFULLY SHOWETH:

- i. The Government of Gujarat has published Gujarat Solar Power Policy, 2015 vide G.R. No: SLR/11/2015/2442/B dated 13.08.2015.



- ii. The Hon'ble Commission vide Order No. 03 of 2020 Dated 08.05.2020, decided the Tariff Framework for procurement of power by distribution licensees and others from Solar Energy Projects and other commercial issues for the State of Gujarat. The above order has been issued under Gujarat Solar Policy 2015 as amended from time to time.
- iii. Under the aforesaid order, Hon'ble Commission had specified certain relaxations and provisions in respect of solar projects set up by MSME (Manufacturing) Enterprises in accordance with the provisions of Gujarat Solar Policy 2015 as amended vide G.R. No: SLR/11/2015/2442/B1 dated 26.09.2019. The copy of GR is placed herewith as Annexure A.
- iv. Thereafter, Hon'ble Commission had issued Suo-Motu Order No. 06 of 2020 dated 05th August, 2020 to remove difficulties in implementing Order No. 3 of 2020 dated 08.05.2020 in which certain provisions regarding Solar Projects to be set up by MSME (Manufacturing) Enterprises were also amended.
- v. Now, the State Government vide G.R. No: SLR/11/2015/2442/B1 dated 01.09.2020 has further amended Gujarat Solar Policy 2015 pursuant to representations from various MSME consumers on the provisions of Clause No: 5 & 6 of G.R. dated 26.09.2019 in relation to energy accounting of wheeled solar energy by MSME (Manufacturing) Enterprises and rate for purchase of surplus power. The copy of above GR is furnished herewith as Annexure



B for kind consideration of Hon'ble Commission. The amendments notified by State Government vide this GR are briefly brought out as under:

"The Clause - 5 stands modified as under:

5. Energy Accounting: The energy accounting shall be carried out on 07:00 hours to 18:00 hours basis of the same day instead of 15 minute time block basis. That means, the generated solar energy can be consumed during 07:00 hours to 18:00 hours on the same day instead of 15 minute time block.

The Clause - 5 stands modified as under:

6. Purchase of surplus power: Any surplus solar energy not consumed by consumer as per Energy Accounting shall be purchased by DISCOMs at Rs. 2.25/unit instead of Rs. 1.75/unit."

- vi. In addition to above amendments, it has been stipulated in the GR dated 01.09.2020 that the amendments shall be applicable for cases registered after the date of publication of GR. Further, it has been provided in the GR that in respect of cases registered prior to issuance of GR, the provisions of this GR shall be applicable to them if they desire to avail the benefits of this GR.



- vii. The petitioner humbly submits that there is a need for issuing appropriate amendments in the order dated 08.05.2020 and 05.08.2020 issued by Hon'ble Commission.
- viii. In view of above, Hon'ble commission is humbly requested to issue appropriate amendments in tariff framework notified vide orders dated 05.08.2020 and 08.05.2020 in respect of relaxations granted to Solar Projects set up by MSME Enterprises on the aspects of Energy Accounting and Purchase of Surplus Power by DISCOMs to enable DISCOMs to implement the amendments issued by State Government vide GR dated 01.09.2020 in Gujarat Solar Policy 2015.
- Viii-a The Petitioner submits that in order for the DISCOMS to implement the amendments to the Gujarat Solar Policy 2015 notified vide GR dated 01.09.2020, there is a need for issuing appropriate amendments in the GERC (Net-Metering Rooftop Solar PV Grid Interactive Systems) Regulations, 2016 notified by Hon'ble Commission. Accordingly, the Petitioner requests the Hon'ble Commission to initiate the appropriate proceedings for amendment in the said Regulations."
- ix. PRAYER - The Petitioner most respectfully prays to the Hon'ble Commission;
- (a) To admit the present petition.
- (b) To issue appropriate amendments in tariff framework notified vide orders dated 05.08.2020 and 08.05.2020 to enable



DISCOMs to implement the amendments issued by State Government vide GR dated 01.09.2020 in Gujarat Solar Policy 2015.

PREAMBLE:

State Government has published Solar Power Policy, 2015 vide G R No. SLR/11/2015/2442/B dated 13.8.2015. Further, Government vide GR dated 13.4.2017 amended provisions related to installation of residential Rooftop solar plants wherein solar capacity restriction is removed.

The government policy has been instrumental in providing conducive framework for development of solar power projects in the State. This has resulted into significant solar capacity addition in the State. Since the notification of Solar Power Policy 2015, there has been significant technological development in the field of solar power generation and cost associated to installation of solar power project.

Under the changed scenario, it was under consideration of the State Government to amend the provisions of Solar Power Policy 2015. Further, it was also under the consideration of the Government to provide special dispensation in policy to Micro, Small and Medium Manufacturing Enterprises (MSME) so that MSME (Manufacturing) can arrange affordable power by setting up solar capacity as per their consumption requirement.

RESOLUTION:

Accordingly, State Government is pleased to amend the Policy GR No: SLR/11/2015/2442/B dated 13.8.2015 for Solar Project(s) set up by MSME (Manufacturing) as under:

Amendments In Gujarat Solar Power Policy-2015



1. **Solar Installed Capacity:** In respect of Micro, Small & Medium Enterprises (MSME) - Manufacturing consumers across the State, Micro, Small & Medium Manufacturing Enterprises shall be allowed to set up of Solar Projects of any capacity, irrespective of its sanctioned load/contract demand with the concerned DISCOM.

- It is further clarified that the MSME (Manufacturing), can set up the above referred capacity either on roof top under net metering or ground mounted for wheeling of power for its own captive use.
- Further, the MSME can purchase solar power for consumption from third party.
- For the purpose of these amendments, the definition of Micro, Small & Medium Manufacturing Enterprises shall be in accordance with Micro, Small & Medium Enterprises Development (MSMED) Act, 2006.

As per Micro, Small & Medium Enterprises Development (MSMED) Act, 2006, definition of MSME Manufacturing category is as below:

Manufacturing Enterprises- The enterprises engaged in manufacture or production of goods pertaining to any industry specified in first schedule to Industries (Development and regulation) Act, 1951) or employing plant and machinery in the process of value addition to the final product having a distinct name or character or use. The Manufacturing Enterprises are defined in terms of investment in Plant & Machinery.

Type	MANUFACTURING
	Investment in Plant & Machinery
Micro Enterprises	Not more than Rs. 25 Lakhs
Small Enterprises	More than Rs. 25 Lakhs but does not exceed Rs. 5 Crores
Medium Enterprises	More than Rs. 5 Crores but does not exceed Rs. 10 Crores

2. **Transmission and Wheeling Charges & Losses for wheeling of power for Captive use / Third Party:** Transmission and Wheeling Charges & Losses for wheeling of power for Captive use / Third Party shall be applicable as



applicable to normal Open-Access Consumer determined by GERC, as amended from time to time.

3. **Electricity Duty:** Electricity Duty shall be applicable at applicable rate. Amount of Electricity Duty recovered shall be paid to DISCOMs towards cross subsidization.
4. **Cross Subsidy Surcharge & Additional Surcharge:** Cross Subsidy Surcharge & Additional Surcharge shall be applicable as applicable to Normal Open Access consumers in case of Third Party Sale.
5. **Energy Accounting:** The energy accounting shall be carried out on 15 minute time block basis. That means, the generated solar energy shall be consumed within same 15 minute time block.
6. **Purchase of surplus Power:** Any surplus solar energy not consumed by consumer as per Energy Accounting shall be purchased by DISCOMs at Rs. 1.75/unit.
7. **Energy drawal from DISCOMs:** Drawal of energy by consumer from DISCOMs after adjustment of solar energy shall be billed as per Tariff applicable to respective tariff category Consumer.

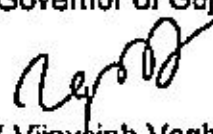

The matter was under active consideration of the State Government to amend the provisions of G.R. dated 26/09/2019 in order to remove difficulties faced by MSME (Manufacturing) Enterprises for taking benefits of special dispensation provided under the GR.

RESOLUTION:

Accordingly, The State Government is pleased to amend the Clause No: 5 & 6 of G.R. dated 26/09/2019 for Solar Project(s) set up by MSME (Manufacturing) as under:-
