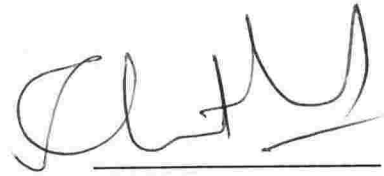

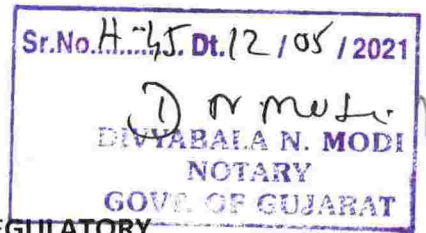
3. The Petitioner further submits that it has published the notice on 11th May, 2021 in the newspapers in accordance with the Hon'ble Commission's direction.

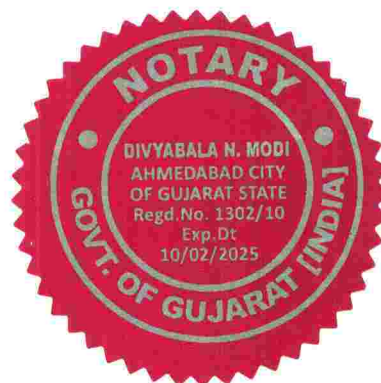
