After CM orders, TMC leader held in violence case

Despite being informed of tension in village, Anarui did not act: Mamata

EXPRESS NEWS SERVICE KOLKATA, MARCH 24

TMC's RAMPURHAT block president Anarui Hussain was arrested in connection with the Birbhum killings, hours after Chief Minister Mamata Banerjee directed the police to apprehend him following his visit to the Bogtui village on Thursday.

"He was arrested from Taraphi," said an officer. However, he refused to speak much on the issue.

According to sources, villagers said that a mob had gathered to set fire to houses but he took no action. After the CM ordered his arrest, the police surrounded his house and also carried out searches at other places. However, he was eventually nabbed from a hotel in Taraphi. The police said they tracked him down using his mobile phone location.

During her visit to Bogtui village on Thursday, Banerjee told DGP Manoj Malaviya, "Anarui is our block president. They (the villagers) held him (about the possibility of arson). But no action was taken. Anarui will be arrested. Why didn't Anarui inform me about the police on time? Anarui will either surrender or be arrested."

"The SDPO and the IC were at tension was prevailing. If police had acted on time, the incident could have been

averted," Banerjee said. Police said Anarui's arrest has taken the number of people arrested in connection with the violence to 22. Of them, 20 have already been produced in court.

The BJP, however, questioned why the police could only track down Anarui after the CM ordered him to be arrested. It is clear that the investigation is not moving in the right direction. He wasn't absconding. The police knew where he was but how can anyone be arrested unless the CM says so. "BJP state president Sukanta Majumdar, who was part of a criminal party delegation which visited the village on Thursday, said:

"They (BJP) find issues with everything. They raise a hue and cry when someone is arrested and even when someone is, they raise questions over it. They have plenty of free time but we have been elected for a purpose, which is to work for the betterment of the people."

said a TMC leader, who did not want to be identified. Also following the CM's orders, the state DGP and IGP have directed SPs of all districts and CPs of all constituencies to launch a ten-day special drive to uncover and arrest all illegal arms and ammunition.

The range DGOs and local KAs, as well as the ADGs shall visit all districts and personally supervise this drive.

SDPO suspended after CM rebuke over 'negligence'

BIRBHUM POLICE on Thursday suspended Rampurhat sub-divisional police officer (SDPO) Shayan Ahmed in connection with the Bogtui village arson that claimed eight lives, and put him on "transitional waiting," said a senior officer. The suspension came hours after Chief Minister Mamata Banerjee lambasted a few police officers in Rampurhat, stating "negligence of duty" possibly led to the incident.

Eight people, including two children, were burnt alive in Bogtui village earlier this week in a suspected fallout of a TMC panchayat deputy chairperson's murder.

The Congress and CPM too criticized the state police for waiting for an instruction from the Chief Minister to act in a murder case. State Congress president Adhir Chowdhury said "It is like giving a kill shot to the people. It is

like Anarui has been told to stay in jail for some time as a damage-control exercise. This is being done under pressure."

CPM state secretary Mohammed Sahab said, "Mamata Banerjee said that Anarui did not send police to the area following the incident. This means that Anarui controlled the police and TMC leaders in several blocks have controlled over police and incursions." Addressing reporters in New Delhi, party spokesperson Sanjay Patra said the killings had paralysed all activities in the area, including political rallies and meetings. Mamata Banerjee is showing no concern (altruism) but acting like a nirmata (crusader).

HC reserves order as state govt opposes central probe

THE CALCUTTA High court on Thursday reserved its order in a suo moti petition, along with a bunch of public interest litigations (PILs) seeking a probe by CBI or National Investigation Agency (NIA) in the death of eight people in West Bengal's Birbhum district.

The state opposed the prayer for CBI or NIA probe, submitting that an inquiry is being conducted by a Special Investigation Team formed by the West Bengal government. A division bench comprising Chief Justice Prakash Shrivastava and Justice R Bhattacharya will consider the arguments and pass the order.

Additional Solicitor General V Dastur submitted that the CBI or

the NIA are ready to initiate a probe if an order is passed by the high court to that effect.

He informed the court that a three-member team from Central Forensic Science Laboratory (CFSL), Delhi, will arrive in Birbhum village tomorrow morning to collect samples from the crime scene as ordered by the bench earlier.

Advocate General SN Mookherjee placed the case diary of the criminal case lodged in connection with the matter along with a report on the investigation being carried out, as directed by the court.

He opposed prayers by petitioners for transfer of the case to CBI or NIA and cited several earlier judgments that different courts in support of his argument.

Opp leaders visit Bogtui, accuse govt of 'cover-up'

LEADERS of opposition parties in West Bengal on Thursday visited Bogtui in Birbhum district where eight people were charred to death in their houses were set on fire in a suspected fallout of a TMC panchayat deputy chairperson's murder.

State Congress president Adhir Chowdhury, whose car was allegedly stopped more than once before reaching Bogtui, alleged that several bodies had disappeared from the site of violence. He set on a dharna on Shrinagar Road in protest against the police action. He said, "The CM alleged a hijacking by behind this incident and that is why she has instructed the police to take strict action. The bodies of two children have gone missing. The CM is trying

TMC delegation meets Amit Shah in Delhi, seeks Governor's ouster

A DELEGATION of Trinamool Congress MPs on Thursday met Union Home Minister Amit Shah and demanded the removal of West Bengal Governor Jagdish Chandra, describing him as a "threat to parliamentary democracy" even as political heat over the Birbhum killings continued to rise.

In a letter to Shah, signed by TMC Lok Sabha and Rajya Sabha floor leaders Sudip Bandopadhyay and Derek O'Brien, the party claimed the "hundreds of innocent lives lost" in the killings of eight persons in the incident was not an outcome of any political confrontation.

After meeting Shah, Bandopadhyay, who led the TMC delegation, said the representatives of

have demanded that Chandra be removed, a point they also made in their letter to Home Minister. "Chandra has become a threat to the parliamentary democracy of the country. He is a person who is not only a threat to the federal structure of the country but also a threat to the government and the constitution of the country," the letter said.

The TMC added that the Governor's intervention in the "ouster of the Opposition" in Bengal. The TMC MPs also handed over to Shah a copy of a letter directed Chief Minister Mamata Banerjee's letter to Chandra on the issue, asserting that the West Bengal Police will not spare any guilty person and make arrests as early as possible.
