SIACHEN IS India's capital of "courage, grit and determination", Defence Minister Rajnath Singh said on Monday after carrying out an on-the-ground review of the security situation at the world's highest snow-clad battlefield.

Addressing soldiers at a forward post at an altitude of 15,100 ft, Singh lauded the "iron-clad" will of the Indian Army soldiers deployed in the icy cold glacier and said that their bravery will forever be an inspiration for future generations. The defence minister described Siachen as a symbol of India's sovereignty and determination for all of us, he said. The defence minister was accompanied by Chief of the Army Staff Gen Manoj Pandey, General Officer Commanding-in-Chief of Northern Command Lt Gen M V Suchindra Kumar and General Officer Commanding of 14 Corps Lt Gen Rashim Bali.

In his remarks, Singh lauded the soldiers for walking on the virtuous path of protecting the motherland with valour and determination in extreme conditions. "We are leading a peaceful life as we have an assurance that our brave soldiers stand steadfast at the borders," he said.

Singh said that the first lamp on Diwali and the "first colour" of Holi should be dedicated to the protectors of the country, similar to the first food offered to deities, priests and gurus.

"Our soldier is no less than any protecting deity," he said.

"In the times to come, when the history of national security is written, the acts of bravery and iron-clad will of our soldiers in the icy cold glacier will be remembered with pride. It will forever be an inspiration for future generations," he said.

Rajnath lauds 'iron-clad' will of soldiers in Siachen

SIACHEN is India's capital of courage, grit and determination, Defence Minister Rajnath Singh said on Monday after carrying out an on-the-ground review of the security situation at the world's highest snow-clad battlefield.

Addressing soldiers at a forward post at an altitude of 15,100 ft, Singh lauded the "iron-clad" will of the Indian Army soldiers deployed in the icy cold glacier and said that their bravery will forever be an inspiration for future generations. The defence minister described Siachen as a symbol of India's sovereignty and determination. He said that just as Delhi is India's national capital, Mumbai is the financial capital and Bengaluru is the technology capital, Siachen is the "capital of courage, grit and determination".

The Siachen glacier in the Karakoram range is known as the highest militarised zone in the world where the soldiers have to battle frostbite and high winds. Singh's visit to Siachen came over a week after the Indian Army marked the 49th year of its presence in the strategically key region following the "Operation Meghdoot". The defence minister described the operation, which was launched by the Indian Army in Siachen on April 13, 1984, as a golden chapter of the country's military history. "The success of Operation Meghdoot is a matter of pride for all of us," he said. The defence minister was accompanied by Chief of the Army Staff Gen Manoj Kumar, General Officer Commanding-in-Chief of Northern Command Lt Gen M V Suchindrar Kumar and General Officer Commanding of 14 Corps Lt Gen Rashmi Bhat.

In his remarks, Singh lauded the soldiers' walking on treacherous paths of protecting the notoriety with valour and determination in extreme conditions. "We are leading a peaceful life as we have an assurance that our brave soldiers stand steadfast at the borders," he said.

Singh said that the first lamp on Divali and the "first colour" of Holi should be dedicated to the protectors of the country, similar to the first food offered to deities, priests and gurus.

"Our soldier is a priest that any protecting deity," he said. "In the times to come, when the history of national security is written, the acts of bravery and iron-clad will of our soldiers in the icy cold glacier will be remembered with pride. It will forever be an inspiration for future generations," he said.

CID to probe college student murder, says Karnataka CM

THE KARNATAKA government Monday handed over the investigation into the murder of Congress corporator's daughter Neha Hiremath on a college campus to the Criminal Investigation Department (CID) and said that the parents have demanded "stringent punishment" for their son and the accused in the case.

Karnataka Chief Minister Siddaramaiah told media persons in Shivamogga that the investigation into the "Hubballi murder" will be handed over to the CID. We will form a special court to ensure a charge sheet is filed and trial of the case is concluded in a time-bound manner.

Neha, 21, the daughter of Congress corporator of Hubballi-Dharwad Municipal Corporation Narayan Hiremath, was a first-year Masters student at BVB College, Hubballi. She was stabbed to death on April 18 allegedly by former classmate Fayaz Khodnadi for rejecting his advances.

The incident on the college campus has given ammunition to the BJP to corner Congress.
